# **Fast Start for House of Delegates**



Dr. Ronald D. Woody opens First House of Delegates meeting

he first meeting of the newly formed ACP House of Delegates convened on October 27, 1993 in Palm Springs. By the time the meeting ended that afternoon, the 47 delegates had approved numerous resolutions and motions with far-reaching effects on the College and the specialty.

The House approved in principle the ACP Contingency Proposal Regarding the Federation of Prosthodontic Organizations. After intense debate and numerous amendments, a consensus was reached and the document was approved.

The document will be distributed for comment to the communities of interest, including the ACP sections and the member organizations of the Federation of Prosthodontic Organizations. The Board of Directors will consider this issue at its February and June meetings. The House is expected to take final action on the document at its November meeting in New Orleans.

The House also approved in principle the creation of an Affiliate Dentist Status and an Affiliate Dental Technician status in the College. Details of such categories will be proposed and presented to the House in 1994. The Membership Committee was also directed by the House to study the issue of possibly requiring ACP members to be members of the ADA.

In other actions, the House approved the advanced specialty education standards for prosthodontics and directed that the document be sent to the ADA Commission on Dental Accreditation. The Commission subsequently voted to approve the document for circulation to the appropriate communities of interest for review and comment. The Commission will hold an open hearing on the proposed new accreditation standards on March 12, 1994 from 1:30 p.m. to 2:00 p.m. in Seattle during the 1994 annual meeting of the American Association of Dental Schools.

The House also approved the five-year Goals and Objectives that were developed by the Ad Hoc Committee on Goals and Objectives.

In conducting its business, the House relied on four reference committees to consider resolutions, discuss issues, and report back to the entire House. Comments regarding the reference committees were encouraging, and the entire experience of the first House of Delegates was considered positive.

According to Dr. Peter F. Johnson, "The purpose of the House of Delegates is ensure that the College members at the grass roots level provide the governance for the College. I am sure that the House will devise its own rules and procedures over time, but the first meeting was a great success."

The House of Delegates replaces the old business meeting and provides a formal mechanism for members elected by their sections to actively participate in the governance of the College. •

## **JOP Editor Takes the Lead**

r. Patrick Lloyd's tenure as Editor-in-Chief of the Journal of Prosthodontics (JOP) is only a few months old and already big changes are in the works. Recently I discussed this topic with Dr. Lloyd. His heightened enthusiasm for the task at hand was quite evident as he shared his aspirations for the JOP.

Lloyd explained that the JOP has multiple roles, providing the discipline with timely scientific information while advancing the specialty of prosthodontics both inside and outside the profession of dentistry.

"The flow of new manuscripts into the Editorial office has been steadily increasing over the past several months," said Lloyd.

# **President's** Report

Howard Landesman, in his keynote "I'm a Prosthodontist, You're a What? - Update 1993" at the Annual Session, noted that prosthodontics has been the fastest growing specialty over the last 10 years by far. Prosthodontics is becoming known and recognized.

This is an exciting time to be a member of the ACP. It is a period of bold expansion of the College's responsibilities and aspirations. The ACP has been placed in the leadership position of the specialty, and the College must be responsive and enterprising.

The ACP has undergone a rapid evolution. Tribute must be given to the founders of the College for perceiving a need and providing a vision to the specialty. Their early nurturing guided the College from its birth to growth and accomplishment. The more recent leadership of the ACP has had the foresight to chart a path, negotiate compromise, and rally support to unite the specialty of prosthodontics. The guidance of Drs. DeSteno, Kuebker, Bergen, Fowler, Holmes and Eggleston have propelled the College to its position of prominence in the specialty.

In the past year, Dr. Woody has launched the ACP on its expansive projection of the image of prosthodontics. He admirably hosted two immensely successful meetings of the Dental Specialties Group in Chicago and San Francisco. At these meetings, he arranged for interchange with the leadership of the ADA, its Council of Dental Education, and the officers of the American Association of Dental Schools (AADS). Drs. Woody and Schwab should be commended highly and, indeed, have received such praise from the other specialty organizations.

In addition, during Dr. Woody's tenure, the College established a downtown Chicago office in proximity to other associations, held a Goals and Objectives workshop under the proficient direction of President-Elect Carl Schulter to give the ACP direction over the next five years, held the first invigorating House of Delegates meeting, and implemented a pilot public relations program. Dr. Woody needs to be congratulated on a year of exemplary command and accomplishments.

Accolades are also due to Annual Session Chairman Charles Goodacre and his many committee members for the great meeting in Palm Springs. The magnificent California fall desert weather, a dynamic scientific session, and western entertainment and hospitality made it a session not to be missed. Obviously, the College is the most important prosthodontic meeting of the year. Now it is time to set the course for the coming year. And as Ron promised me, he did not solve all the problems or do all the work.

As the College's duties and obligations expand, its administration needs to respond to innovative needs and to offer exceptional service to the membership.

In response to the Goals and Objectives workshop and the corresponding survey of younger College members, the major endeavor over the next several years is to validate prosthodontics to the public and the professions. Dr. Schwab, the Public and Professional Relations Committee, other committees, hired experts, the College Officers and Board of Directors, and all members of the ACP need to be involved in this effort. A significant part of the 1994 College budget is being devoted to this cause. Public and professional awareness is of paramount importance to enable the specialty to reach its goals in all its spheres of concern: private practice, education or government service. In championing the specialty, you will all be advancing your own professional aspirations.

The expanded Board of Directors, the House of Delegates, and the College Sections representing all but 76 members, are avenues of creating input into the governance of the College from all segments of the membership. This should instigate a period of new involvement by the members in the activities of the College at the local, state and national level. The more vitality and energy present in College activities, the greater the College can benefit its members.

As the College's duties and obligations expand, its administration needs to respond to innovative needs and to offer exceptional service to the membership. The benefits of having an Executive Director and of having an office in Chicago have been very apparent. We have progressed from the incipient stages when the records of the College were transferred from Secretary to Secretary, and their wives did much of the College administrative work.

Much belated gratitude should be extended to Helen Rudd, Sally Johnson, Peggy Sproull and Joan Kuebker for their many years of loyal devotion and sustenance to the College.

The College has outgrown its current staff. It needs specialized personnel to minister to membership requirements, and it needs a larger office to house the services provided. In the next year, Dr. Schwab, Linda Wallenborn, the Officers and the Planning Committee will be working on a plan to accomplish these goals. Obviously with greater responsibility and service there will be more costs. This will be something the membership must be willing to bear.

The House of Delegates voted to present a proposal to the Member Organizations of the Federation of Prosthodontic Organizations outlining a means of preserving a forum for prosthodontic organizations if the FPO decides to discontinue. The well intentioned offer was made in order to provide an arena for these organizations to discuss common interests, to enable them to speak to organized dentistry through the voice of the College, and to hopefully strengthen prosthodontics through unity. The College stands ready to respond to the wishes of the FPO member organizations to either support the FPO, or to assume leadership for both the specialty and discipline. In addition, the House directed the Board of Directors to investigate the merits of the affiliation of non-prosthodontist dentists and dental laboratory technicians with the ACP. The overriding goals of these two actions are to achieve that which is best for prosthodontics.

Other very important activities are already underway in response to the new Goals and Objectives and to other established needs. A Committee is going to develop the "Parameters of Care in Prosthodontics" to reflect those established in oral and maxillofacial surgery, periodontics, orthodontics and pediatric dentistry. It is essential that the specialty do this or it will be imposed on us by an outside agency.

A mechanism for the 1994 review of dental undergraduate teaching standards relevant to prosthodontics will be set up, new areas of fiscal development will be explored, and stronger ties with the laboratory industry will be established. In addition, our first joint conference, with the Academy of Periodontology, will take place in July in Chicago.

An organization is the aggregate of its members. Many of the College members devote numerous hours of personal time to further the progress of prosthodontics. These members deserve much more than the few acknowledgments they are given. There is always much to do. I encourage all members of the College to be involved at some level so that the specialty can grow and receive the recognition that we all know it deserves. •

# **Successful First Year for Matching Program**

his is the first year for Prosthodontics to participate in the Postdoctoral Dental Matching Program. A program designed for ease and efficiency when making selections.

Currently, over half of the prosthodontic programs across the country are participating in the matching program. A total of 52 positions in prosthodontic programs were filled in this year's match. While this is a good start for the introductory year, higher rates of participation are essential for a smooth operation for the Matching Program. Many program directors not yet registered have stated that they want to "see how it goes" the first year before deciding to participate in the match.

In the long run, the degree of success for the matching service will be related to the number of participating post-graduate prosthodontic programs. This has been shown with other specialties currently participating in the Matching Program. According to Dr. Art Nimmo, ACP Director of Education, "The match program is for everyone's good, but it is especially good for the specialty in that it raises its level of credibility and reputation."

# **College Makes Presence Felt at ADA Meeting**

ollege President Dr. Peter F. Johnson,
Immediate Past President Dr. Ronald D.
Woody, and Executive Director Dr.
David Schwab were among the individuals
who represented the specialty of prosthodontics at reference committees at the ADA
annual session in San Francisco in November.

College representatives provided testimony on a wide range of issues, including laboratory matters and the proposed creation of a new specialty of implantology. The College opposed the creation of any new specialties at this time, and the ADA House of Delegates voted to maintain the status quo of eight recognized dental specialties.

In addition, the ADA meeting provided the backdrop for the Dental Specialty Group meeting, which the College hosted this year. The Dental Specialty Group is an informal gathering of representatives of the recognized specialties. The task of hosting the meeting rotates among the specialty organizations. In 1993, the it was prosthodontics turn and the College served as host.

At the invitation of Dr. Woody, representatives of the American Association of Dental Schools also attended the meeting. The specialties were particularly concerned about two issues: that program directors of advanced specialty education programs be board certified and that the recognized dental specialty organizations be granted standing representation on the Commission on Dental Accreditation.

Subsequent to the meeting, AADS advised the ACP the first issue would be considered by the AADS House of Delegates and the second would be considered as part of a larger study of dental accreditation being undertaken by AADS.

Plans are underway for additional representation from the College at the next ADA annual session in New Orleans.


"With this volume of articles, I envision the JOP to be published on a bi-monthly basis by 1996 and a monthly basis within five years."

I asked Dr. Lloyd about changes in the format. "Starting with the spring issue of 1994 we will be celebrating a new section to the journal which will be a collection of abstracts," Dr. Lloyd noted with obvious pride. "We're putting together a separate editorial board headed by Dr. Rhonda Jacob, who is an Associate Professor of Dental Oncology at the M.D. Anderson Hospital in Houston, Texas. This new board will be responsible for scanning the literature and providing our readership with abstracts of publications that meet particular criteria that will be spelled out in that particular issue of the journal. This will enhance the opportunity of our readers to quickly scan through articles that have been identified as good clinical and basic science."

"We are going to heavily emphasize publications dealing specifically with the specialty of prosthodontics and less with restorative dentistry. Our journal is the only prosthodontic journal that is published by a specific organization and a big distinction is the organizational affiliation that we have."

Two new section editors have joined the Editorial Board since Lloyd became the Editorin-Chief. Dr. Dale Cipra, Director of Postgraduate Prosthodontics at Ohio State University School of Dentistry, will be replacing Dr. Lloyd as the new "Topics of Interest" editor. The vacancy created by Dr. Dean Johnson's retirement as "Academics and Education" editor will be filled by Dr. Arthur Nimmo. Art is the Chairman of Prosthodontics at the University of Detroit Mercy School of Dentistry and has for a number of years chaired the ACP's Education and Advancement Committee.

"As new appointments are made to the Editorial Board, I will be looking for individuals who represent different geographic areas in

the country, have both academic credentials and private practice experience, and are Board Certified specialists," Lloyd explained.

Dr. Lloyd indicated that every year at the annual session starting in 1994, the JOP will sponsor a one-half day workshop for individuals interested in publishing within the journal. Guidelines for authors, editorial review policy, and speakers discussing topics related to scientific writing will be included in these mini-courses. Dr. Lloyd envisions that in years to come, these experiences will encourage a larger body of writers, make College members the best prepared writers for the Journal, and supply writers with as much information as possible to insure a successful submission.

There will be a number of unique features of the Journal relative to other publications. "We are going to heavily emphasize publications dealing specifically with the specialty of prosthodontics and less with restorative dentistry. Our journal is the only prosthodontic journal that is published by a specific organization and a big distinction is the organizational affiliation that we have," Lloyd said.

Another distinction unique to the JOP, according to Dr. Lloyd, involves the editorial review process. The Journal is moving away from the standard reviewing pool found traditionally with other journals.

"We're going to use the widest body of reviewers available. The type of manuscript that we're getting today is so discipline specific and technical that we're having to reach way out to ensure that the papers are being reviewed by the most competent people within a field."

The reviewers will be found within and outside the ACP and can include anyone that has an expertise in a particular field. By expanding the pool of reviewers, Dr. Lloyd hopes to do a number of things including: 1. Make sure that the content of manuscripts are satisfactory to the wider body of reviewers, 2. Increase the exposure of our journal to people who may not be aware of its availability for publication and, 3. Encourage people to consider our journal as a new alternative for publication.

"The JOP will also fulfill a significant responsibility to the specialty by reaching out to the general practitioners and educating them in the fundamentals of the discipline," he said. "Hopefully, the literature provided through our journal might serve as a stimulus for generalists to refer patients who have complex problems onto specialists once they are made aware of some of the services available through our specialty."

# **Educators/Mentors Focus on Computer Based Education**

he Educators/Mentors seminar featured three presentations of different aspects of computer based education currently being used in the dental and medical schools in the United States. The topics covered were an eye-opening experience for the computer novice and a terrific confirmation of the media for the experienced computer user.

Dr. John Nequlesco demonstrated the Genesis PC Program for branching instruction in sectional anatomy. The program has a detailed head and neck anatomy portion that would be a very useful supplement in the anatomy requirement for postgraduate prosthodontic programs.

Dr. Frank Wiebelt demonstrated a program for the design of removable partial dentures and an artificial intelligence program. The idea of a computer based expert program for the design of removable partial denture frameworks caused the greatest debate in the panel discussion.

Dr. Meade van Putten utilized the Macintosh II for the education and monitoring of complete denture prosthodontics. The use of the visual capability of the software made esthetic and phonetic problems in prosthodontic procedures

graphically evident to both instructors and students.

The Educators and Mentor seminar was designed not only for those active in academia but for all interested in becoming better teachers.

Future topics will include: Program outcome assessments; curriculum design to meet the new ADA Standards for Advanced Specialty in Prosthodontics; resident evaluation methods and review of the new board format.



## Technician Shortage Concerns Lab Owners and Dentists

Low pay and unstable working conditions are among the reasons that fewer individuals are entering and remaining in the dental laboratory industry, reports the July/August 1993 Trends & Techniques.

"A sharp decrease of competent people choosing their careers as dental technicians is creating great concern among dental laboratory owners throughout the country," says Laury Stafford, CDT, of Salem, Oregon.

According to Stafford, who has 32 years of dental laboratory experience, many qualified, experienced dental technicians are leaving the field to work in other industries where their skills are in demand.

Dentists should be concerned, too, about the labor crisis facing the dental laboratory profession, says Dr. James P. Fratzke, of Salem, Oregon.

"The technician plays a vital role in the quality of dentistry we deliver to our patients," he says. "Encouraging competent people to enter this profession must be a primary objective for dentistry."
